



THE CLUB'S RULES AND REGULATIONS

In these **RULES AND REGULATIONS**, the words enlisted shall have the following meanings:

DEFINITIONS

- **OPERATING AGENT:** The individual or Company appointed by **THE CLUB** to manage and control **THE CLUB** operations.
- **RULES AND REGULATIONS:** correspond to the present formal and official document where the Member may review the scopes and provisions for its access and permanence at **THE CLUB**. The Rules and Regulations may be changed at the discretion of **THE CLUB**.
- **THE CLUB FACILITIES:** private physical facilities that include: a 25-meter lap pool with four swim lanes, adult lounging pool and Jacuzzi, seating and comfortable lounge chairs, family pool, Beach Club Restaurant, Cocktail Bar, exercise room with weightlifting and cardio equipment and social areas for entertainment.
- **THE MEMBER:** A person representing his or her property, whether built or unbuilt, in his or her desire to use and enjoy **THE CLUB FACILITIES**. All Members must keep their Membership duly registered and up to date. In the event that a property is owned by a company, the owner of said company must provide proof of said ownership by appropriate means (capital stock certificates, certified copy of the company books, or certified contract of the purchase of shares or assignment of each Quota). In the cases in which the property is owned by a company, only one person shall be designated as Member, therefore only the Member's family nucleus/Direct Beneficiaries (as herein defined) will be granted the benefits associated with the Membership.
- **THE MEMBERSHIP:** is the right to use **THE CLUB FACILITIES** that any Member has, once the corresponding Agreement has been signed and the **ENTRY FEE** has been paid.
- **THE MEMBERSHIP ID:** is the official ID document or mechanism provided to each Member and/or Multimember of **THE CLUB** and that enables its condition. This card / number is personal, exclusive, and non-transferrable pursuant to the conditions set forth by **THE CLUB**.
- **MONTHLY PROGRAM FEE:** a periodic payment that enables access to the **THE CLUB FACILITIES** and defines whether **THE CLUB** Member is active or inactive. **THE CLUB** may define the periodicity to charge the Fee.



- **SPECIAL EVENT:** is defined as a previously organized activity in which a client (Member or not) by means of an agreement reserves an area and hires food and beverage services. It may be a private party such as a wedding, celebrations such as birthdays, anniversaries, or corporate events, as well as a private event, but of an open nature that requires the sale of tickets to participate in the event. In any case, the use of the areas for a special event shall be coordinated and approved by **THE CLUB**.

THE ENTRY FEE

- **FLAGSHIP ENTRY FEE:** Available from July 1st- Oct 31st, 2024 - **\$2900 USD + 13% VAT**
- **STANDARD ENTRY FEE:** Available Nov 1st, 2024 - **\$6400 USD + 13% VAT**

Memberships are limited.

MONTHLY PROGRAMS

- **SENIORS COUPLE MEMBERSHIP- \$150 USD + 13% VAT per couple, per month**
 - 1 member must be at least 65 years of age or older, includes full access.
- **FAMILY MEMBERSHIP \$225 USD + 13% VAT per month**
 - this pass is valid for the bearer and spouse's immediate family members (this includes, children, parents, grandparents, and grandchildren)
- **HOUSEHOLD MEMBERSHIP**
- **1 BEDROOM HOME \$250 USD + 13% VAT per month**
- **2 BEDROOM HOME \$300 USD + 13% VAT per month**
- **3 – 4 BEDROOM HOME \$400 USD + 13% VAT per month**
- **5 – 6 BEDROOM HOME \$500 USD + 13% VAT per month**
- **7+ BEDROOM HOME \$550 USD + 13% VAT per month**
 - Full access for all bearer and spouse's family members staying in the home; Limited access for non-family guests and renters (sauna/ice bath access available a la carte)

Dues will be charged at the end of each month.



DAILY PASS OPTIONS

- CHILD PASS: From 8 to 12 years old- **\$15 USD + 13% VAT** - \$10 redeemable in consumables, children under 8 there will be no charge. **Limited Access**
- SWIM & GYM PASS -**\$20 USD + 13% VAT** – 7 am to 10 am, hours subject to change. **Limited Access.**
- NON-MEMBER LAS CATALINAS PASS -**\$30 USD + 13% VAT** - \$15 redeemable in consumables **Limited Access.** (Reservations Required) Must be staying within Las Catalinas Condominium.
- MEMBER GUEST PASS- **\$30 USD + 13% VAT** - \$20 redeemable in consumables Member must be Present. **Full Access.**
- DAY PASS -**\$70 USD + 13% VAT** - \$50 redeemable in consumables, accessible for anyone staying off condominium premises (Reservations Required). No Seasonal priority. **Limited Access.**
 - **Limited access** – Gym reservation required, Ocean activities, special events, Sauna, and Cold plunge NOT included
 - **Full access** -to all amenities

All amenities are subject to change.

THE ENTRY FEE AND REFUND POLICY

THE MEMBER understands that if accepted as an eligible **MEMBER**, they must pay **THE ENTRY FEE** and, select one of the **MONTHLY PROGRAMS** available. **THE ENTRY FEE** shall not be refunded to **THE MEMBER** under any circumstances, including but not limited to a later resignation, death, termination of privileges or any other of **THE MEMBERSHIP**.

GENERAL RULES

- The Member, the Beneficiaries, Multi-members, and their Guests shall abide by all Rules and Regulations of **THE CLUB**, as they may be amended from time to time. The Member, Multi-members, and its Guests shall agree to comply with all the Rules and Regulations posted at **THE CLUB FACILITIES**, as applicable by area.
- In addition, The Member, the Multi-members, the Beneficiaries, and their Guests shall comply with the Rules and Regulations of the Las Catalinas Master Condominium, as enacted or amended from time to time by its Board.



- **THE CLUB FACILITIES** will be open on the days and during the hours as may be established by **THE CLUB**. **THE CLUB** reserves the right to close or restrict access to any areas or portions of **THE CLUB FACILITIES**, at its sole discretion, for scheduled maintenance, repairs, to hold events, or for any other purpose.
- Performances by entertainers, other outside vendors, or companies, will be permitted on **THE BEACH CLUB FACILITIES** only with the written permission of **THE CLUB**.
- In no event will **THE CLUB** operator discriminate against any individual because of their race, color, religion, sex, sexual orientation, national origin, age, handicap, or marital status.
- Group activities will only be permitted in areas designated for such purposes by **THE CLUB**.
- Alcoholic beverages will not be served, sold, or permitted to be consumed at **THE CLUB** in any manner prohibited by law. **THE CLUB** reserves the right, at its sole discretion, to refuse service to a Member, Multi-member, Beneficiary, or Guest when said Member, Multi-member, Beneficiary, or Guest appears to be intoxicated.
- Coolers and/or food and beverage containers are prohibited within the **THE CLUB FACILITIES**, except for those duly approved exceptions.
- All food and beverages consumed on **THE CLUB FACILITIES** must be supplied by **THE CLUB** unless otherwise permitted by **THE CLUB**.
- Employees are only authorized to deliver food or alcoholic beverages inside **THE CLUB'S** Restaurant, unless otherwise permitted by **THE CLUB**, without exception.
- Commercial advertisements may not be posted or circulated at **THE CLUB** and solicitations of any kind may be made at **THE CLUB** or on **THE CLUB** stationery without the prior approval of **THE CLUB** operator. Other than as permitted in writing by **THE CLUB**, the petition will be originated, solicited, circulated, or posted on **THE CLUB**.
- The Member and/or Multi-member may not use **THE CLUB** Member roster or list for solicitation or commercial purposes, and the roster may not be distributed to anyone other than a Member and/or Multi-member, without the express consent of **THE CLUB**.
- It is contrary to **THE CLUB** policy to have **THE CLUB FACILITIES** used for functions or fund-raising efforts that benefit a political cause, except as specifically permitted by **THE CLUB**.
- **THE CLUB FACILITIES** shall not be used in connection with organized religious services or other activities; except as approved by **THE CLUB**.



- The Member, the Beneficiaries, and their Guests should not request special personal services from employees of **THE CLUB** who are on duty or the personal use of furnishings or equipment that are not ordinarily available for use by **THE MEMBER**.
- The Member, the Multi-members, the Beneficiaries, and their Guests may not abuse any of the employees of **THE CLUB**, verbally, physically, or otherwise. All service employees are under the supervision of the General Manager of **THE CLUB** and Member, Multi-member, Beneficiary, or Guest may not reprimand or discipline any employee, and a Member may not request an employee to leave **THE CLUB FACILITIES** for any reason. Any employee not rendering a courteous and prompt service should be immediately reported to **THE CLUB**.
- All complaints, criticisms, or suggestions of any kind related to any of the operations of **THE CLUB** or its employees must be in writing, signed, and addressed to the General Manager. Should the complaint be regarding the General Manager, then it should be addressed to the owners of **THE CLUB**.
- Smoking and vaping are not permitted in any area.
- No fireworks are permitted anywhere on the property of **THE CLUB** or adjacent areas unless part of a fireworks exhibit organized and conducted by **THE CLUB** or otherwise properly authorized by **THE CLUB**.
- Firearms and all other weapons of any kind are not permitted on the property of **THE CLUB** at any time, except in the case of security personnel.
- **THE CLUB** General Manager will have or designate appropriate staff who will have full authority to enforce these Rules and Regulations and any infractions will be reported to **THE CLUB** management.
- Violation of any of these rules or conduct in a manner prejudicial to the best interests of **THE CLUB** will subject the person in violation to disciplinary action by **THE CLUB** in accordance with these Rules and Regulations.

MEMBERSHIP CARDS

- **THE CLUB** will issue a Membership Card (or equivalent) to the Member, Multiple Owners and Beneficiaries who are entitled to **THE MEMBERSHIP** privileges. Membership Cards may include the Member's name, account number and membership category, as well as any other information deemed necessary by the Operator of **THE CLUB**. It will also issue jump cards that have the ability of the owners, including bracelets to access **THE CLUB**.



- Membership Cards will only be issued upon payment of Dues by the Member and to those Members in good standing. Membership Cards will not be issued to children under the age of 12 or over the age of 25. The Members, Multi-members and Beneficiaries must always carry their Membership Cards with them while using **THE CLUB FACILITIES**.
- The Membership Card may not be used by any person other than the person to whom it is issued. Membership Cards are non-transferable. The Members, Multi-members and Beneficiaries are asked to adhere to this policy to avoid possible rules and regulations violation.
- In order to protect **THE MEMBER** from improper charges, Membership Cards must be presented at the point of sale for all transactions. For food and beverage purchases, Membership Cards must be presented at the time of placing the order. Furthermore, and to ensure the safety of everyone, The Member, Multi-member, the Beneficiaries, and their Guests should be prepared to identify themselves upon request by staff members of **THE CLUB**.
- They can be picked up at **THE CLUB** reception office. For all renters, the access to **THE CLUB** will be given on the same access card to the house.
- In the event of a lost or stolen Membership Card, **THE CLUB** shall be notified immediately. The card will be canceled and **THE CLUB** will issue a new Membership Card. Until notification of card loss or theft is received in writing by **THE CLUB**, the Member and/or Multi-member will be responsible for all charges placed on the account. A card replacement fee, as determined by **THE CLUB**, in the future may be charged for lost or stolen Membership Cards.
- Each Member, Multi-member, and Beneficiary may receive bracelets, decals and other insignia as **THE CLUB** may designate from time to time and they shall display such insignia as required by **THE CLUB**.

MONTHLY PROGRAMS DUES AND OTHER CHARGES

- Members and Multi-members are entitled to pay directly at **THE CLUB** as long as their **MEMBERSHIP** is current. **THE CLUB** may decide to suspend, eliminate, or alter these privileges as it deems appropriate in the future.
- All of **THE CLUB'S** food, beverages, merchandise, and services charged to the Member/Multi-member's account will be billed weekly and each Member/Multi-member's account will be due and payable upon receipt of the weekly invoice statement. **THE CLUB** reserves the right to propose a spending minimum at **THE CLUB FACILITIES**. All Dues, fees, and charges will be stated and paid in U.S. dollars unless otherwise determined by **THE CLUB**.



- Past due bills will be subject to one and one-half percent (1.5%) late payment charge per month, but not to exceed the maximum amount permitted by law. The late payment charge shall accrue 30 days from the date of the monthly statement until the account is paid in full. Members/Multi-members having past due bills may be charged a reinstatement fee at the discretion of **THE CLUB** to reactivate an account once it is deemed delinquent.
- **THE CLUB** reserves the right to implement a credit card billing system by which all Dues, fees and charges are billed to the approved credit card of each Member/Multi-member. In the event that **THE CLUB** implements such a system, it will give notice of such effect to The Member/Multi-member. Each Member and/or Multi-member must then secure to **THE CLUB** an approved credit card to which the Member/Multi-member authorizes **THE CLUB** to charge dues, fees, and charges. The credit card company shall pay the dues, fees, and charges to **THE CLUB**. The Member/Multi-member will receive a monthly written statement of its dues, fees, and charges, which have been charged to its credit card. The Member/Multi-member agrees to pay promptly and directly to **THE CLUB** any amounts not paid by the credit card company upon written notice from **THE CLUB**. The Member/ Multi-member will be required to always keep a valid approved credit card on file with **THE CLUB**.
- The Member/Multi-member may determine what dues, fees, and other charges shall be billed to its credit card on file with **THE CLUB**, or billed directly to their club account, as provided for in the Membership Agreement. Consumption charges will be billed weekly and all programs monthly, and The Member/Multi-member will receive a statement of its charges.
- If the account of a Member/Multi-member is delinquent, **THE CLUB** may, at its option, take whatever action it deems necessary to obtain proper payment including, without limitation, suspension or termination of **THE MEMBERSHIP** or even take legal action. If **THE CLUB** starts any legal action to collect any amount owed by any Member/Multi-member or to enforce any other liability of any Member/Multi-member at **THE CLUB**, and if the judgment is obtained by **THE CLUB**, the Member/Multi-member will be liable for all costs and expenses of such legal action and reasonable attorney fees, including any fees required in connection with appellate proceedings.

MAILING ADDRESSES

- Each Member/Multi-member shall be responsible for filing with the Concierge Office, in writing on a form provided by **THE CLUB**, its physical mailing address, and at least one email address that need to always be current where the Member/Multi-member wishes all notices and invoices of **THE CLUB** to be sent. A Member/Multi-member



shall be deemed to have received mailings from **THE CLUB** 10 days after they have been mailed to the address on file. In the absence of an address on file at the Concierge Office, any mailing from **THE CLUB** may, with the same effect described above, be sent as **THE CLUB** General Manager deems most likely because of its prompt delivery.

- **THE CLUB** shall be notified in writing of any change of physical or email address. Failure to constitute a waiver of the right to receive notices, bulletins, and any other communications, and a violation of these Rules and Regulations.

MEMBERSHIP CORRESPONDENCE

Complaints or suggestions concerning the management, service or operation of **THE CLUB** should be sent in writing, by the Member/Multi-member and addressed to **THE CLUB'S** General Manager. Errors in billing charges should be directed to the attention of the Accounting Department.

CLUB SERVICES AND ACTIVITIES

- **THE CLUB** will provide a variety of social, cultural, and recreational events in which The Member/Multi-member is encouraged to participate.
- **THE CLUB** wishes to encourage the use of **THE CLUB FACILITIES** by The Member/Multi-member for private functions on any day or evening, provided it does not interfere with the normal operation of **THE CLUB**, or with the services regularly available to the other Members/Multi-members. The Member/Multi-member will need to make reservations with the appropriate personnel from **THE CLUB** for available dates and to make the proper arrangements.
- Private events are permitted at **THE CLUB** only with the prior permission of **THE CLUB** and at such times as **THE CLUB** determines. The individual sponsoring the event will assume all responsibility for the conduct of his or her Guests and payment of applicable expenses associated with the event. The event sponsor will be responsible for any damage to **THE CLUB** Facilities and for payment of any unpaid charges by persons attending the private event.
- Special events and functions may be scheduled from time to time at the discretion of **THE CLUB**.

RESIGNATION OF MEMBERSHIP

- A Member/Multi-member may resign from **THE CLUB** Membership by delivering a written notice of resignation to the emails designated in the Membership Agreement. A Member shall be deemed to have resigned as of the date that is 30 days after **THE**



CLUB receives written notice of the Member/Multi-member's resignation. Resignation is irrevocable unless otherwise determined by **THE CLUB**. Notwithstanding any resignation, the Member/Multi-member and its spouse shall remain liable for any amounts unpaid on the account of the Member/Multi-member at **THE CLUB**.

DISCIPLINE

- The Member/Multi-member is responsible for its own conduct, the conduct of its Beneficiaries, and of its Guests. Any Member/Multi-member whose conduct or the conduct of its Beneficiaries or Guests is deemed by **THE CLUB** as it being likely to endanger the welfare, safety, harmony, or good reputation of **THE CLUB** or to be otherwise unlawful and/or improper; may be reprimanded, fined, suspended, or expelled from **THE CLUB** and may have all privileges associated with **THE MEMBERSHIP** suspended or terminated by **THE CLUB**. **THE CLUB** will be the sole judge of what constitutes improper conduct, but improper conduct will include, without limitation: (i) failing to meet eligibility for Membership, (ii) submitting false information on the Membership Agreement, (iii) allowing its Membership Card to be used by another person, (iv) failing to pay any amount owed to **THE CLUB** in a proper and timely manner, (v) failing to abide by the Rules and Regulations as set forth herein and as established by **THE CLUB** from time to time, (vi) abusing **THE CLUB** personnel or employees, or (vii) acting in a manner incompatible with the standard of conduct of the existing Membership or which would likely affect the reputation of the Member/Multi-member.
- Any Member/Multi-member accused of improper conduct shall be first given a verbal warning of the breach and shall be requested to immediately cease the improper conduct and to correct said breach. This first verbal warning shall be recorded in **THE CLUB** archives. If the Member or Multi-member does not cease and correct the improper conduct, **THE CLUB** shall give them a written warning, stating the improper conduct and time to cure it as well as the consequences of not complying with the requirement, which will be a three (3) day suspension. Further lack to cease the improper conduct may result in the total loss of all rights and benefits associated to **THE MEMBERSHIP** without a refund.
- All written warnings shall give the Member and Multi-member an opportunity to be heard by the General Manager of **THE CLUB** or designated personnel why they should not be disciplined. If such Member/Multi-member wishes to be heard, a time and date (not be less than 10 days thereafter) shall be set for a hearing. While such complaint is being considered by **THE CLUB**, the Member/Multi-member will continue to enjoy the privileges of **THE CLUB**.



- Notwithstanding the foregoing, **THE CLUB** may, without notice and without a hearing, immediately suspend some or all the privileges associated with a Membership, after notice, terminate a Member/Multi-member for failure to pay each due, fees, or any other amounts owed to **THE CLUB** in a proper and timely manner.
- All Membership privileges shall cease upon termination of **THE MEMBERSHIP**. A person whose Membership has been terminated shall be obligated to continue to pay each due until the termination date.

LOSS OR DESTRUCTION OF PROPERTY OR INSTANCES OF PERSONAL INJURY

- Each Member/Multi-member as a condition to become a Member and each Guest as a condition of invitation to **THE CLUB FACILITIES** assumes sole responsibility for their property. **THE CLUB**, will not be responsible for any loss or damage to any personal property used or stored on **THE CLUB FACILITIES**, whether in lockers or elsewhere. Any such personal property which may have been left in or on the facilities for six months or more without payment of storage thereon may be sold by **THE CLUB**, with or without notice, at a public or private sale, or may be otherwise disposed of, and the proceeds, if any, may be retained by **THE CLUB**.
- No Person may remove from the area in which it is placed or from the premises of **THE CLUB** any property or furniture belonging to **THE CLUB** without proper written authorization.
- Every Member/Multi-member of **THE CLUB** shall be liable for any property damage caused by the Member or its Beneficiaries. The cost of such damage shall be charged to the account of the responsible Member/Multi-member.
- Should any party bound by these Rules and Regulations bring suit against any of the Indemnified Parties in connection with any event operated, organized, arranged, or sponsored by **THE CLUB** or on any other claim or matter in connection with a Membership in the **THE CLUB**, and fails to obtain judgment therein against any of said Indemnified Parties, said party shall be liable to the prevailing Indemnified Parties for all costs and expenses incurred by said Indemnified Parties in the defense of such suit, including court costs, attorney fees, and expenses through all appellate proceedings.

CHILDREN AND MINORS

Unless permitted by **THE CLUB**, children under 12 years of age are not allowed at the **THE CLUB FACILITIES** unless accompanied and supervised by a responsible adult of



legal age. **THE CLUB** may designate certain playing times schedules for children under 18 years old or younger.

Minors under the lawful drinking age established by the Costa Rican law as 18 years old are not permitted in otherwise determined by **THE CLUB** at certain designated locations such as the Cocktail Bar.

The Member/Multi-member is responsible for the conduct and safety of its children when enjoying the Club Facilities.

DRESS CODE

General Attire: The Member/Multi-member is urged to choose attire in a manner appropriate to the environment and atmosphere offered within **THE CLUB**. The Member/Multi-member is also expected to inform the Beneficiaries and Guests of the dress requirements. **THE CLUB** may publish dress requirements from time to time. In the gymnasium facilities, tennis shoes and workout attire shall remain mandatory.

GUEST PRIVILEGES

Guest privileges may be extended under rules and policies established by **THE CLUB** from time to time. Guests will be entitled to use **THE CLUB FACILITIES** only in accordance with the privileges of **THE MEMBERSHIP** of the sponsoring Member/Multi-member upon payment of Daily Fees.

Although it is the intention of **THE CLUB** to accommodate Guests without inconvenience to the Members/Multi-members, **THE CLUB** reserves the right to limit the number of Guests that are sponsored by a Member/Multi-member on any given day or over the course of the year.

THE CLUB shall establish from time to time the rate of the daily guest fees, charges, and the Rules and Regulations for use of **THE CLUB FACILITIES** by the Guests.

Guest privileges may be denied, withdrawn, or revoked at any time for reasons considered sufficient by **THE CLUB**, at its sole and absolute discretion. All Guests shall be either house Guests or day Guests. A house Guest is defined as a Guest temporarily residing in the residence of a Member/Multi-member, without the payment of any consideration thereof. All other Guests of a Member/Multi-member will be considered Day Guests.

POOL USE



Use of the pools at all times is at the own risk of the user. Any injuries or accidents should be reported to the attendant immediately.

Children 12 years and younger must be always accompanied and supervised by an adult of legal age.

Children of any age who cannot swim must be always accompanied by a parent or guardian while in any of the pool areas.

Children must be three years of age and toilet trained to use the adult pools. Likewise, children who are not toilet trained must use the appropriate diaper for such purposes (swim diapers).

Swimming is permitted only during the hours of operation that span from 7:00am to 7:00pm. Pools are officially closed when a "CLOSED" sign is posted or when otherwise designated by **THE CLUB**.

Members/Multi-members and Guests are required to shower before entering a pool.

Bottles, glass objects, drinking glasses, and sharp objects are not permitted in the pool areas. Trash should be placed in the proper trash cans located throughout **THE CLUB**.

Food is allowed only in designated areas of the pool and must be purchased from **THE CLUB**.

All swimmers must wear bona fide swimming attire. Cut-offs, dungarees, and Bermuda shorts are not considered appropriate swimwear.

Music devices are only allowed with earphones.

Lifesaving and pool cleaning equipment should be used only for the purposes intended.

Running, ball playing, and hazardous activities are not permitted in the pool areas. Pushing, dunking, and dangerous games are prohibited.

Diving is not permitted unless otherwise indicated at a pool. Fishing, spearfishing, and snorkeling equipment, other than a mask and snorkel, are not to be used in the pool areas except as part of an organized course of instruction.

Throwing footballs, frisbees, tennis balls, or other objects, spitting or spouting water, and tag games are not allowed in the pool areas. The pool staff has the authority to expel from the pool areas anyone who does not follow these rules or whose conduct is otherwise unbecoming of a Member/Multi-member.



All persons using pool furniture are required to cover the furniture with a towel when using suntan oils and lotions, as the use of these oils and lotions could stain or damage the furniture. The Member/Multi-member may be held responsible for any associated cleaning costs if they don't follow this instruction.

Flotation devices are permitted for non-swimming children up to five years of age. Small toys such as balls, water guns, rings, etc., may be permitted, depending on the number of persons in the pool and the way the toys are used. Air mattresses may be permitted, depending on the size of the mattress and the number of persons in the pool. The pool staff has the authority to discontinue use of these mattresses upon the determination that they present a safety hazard or hinder the enjoyment of the pool by others. Tire inner tubes are not permitted at any time.

Persons who leave a pool area for over 30 minutes must relinquish lounges and chairs by removing all towels and personal belongings. Saving chairs for persons absent from the area is not allowed at any time.

Ocean kayaks, body boards, and other equipment made available to the members from time to time shall be made available on a "first come, first served basis" unless equipment has been reserved in advance. Time limits on usage may be established from time to time. The fees and service charges for each use shall be established by **THE CLUB** from time to time. Each Member/Multi-member and its Guests shall be solely responsible for the safe operation and use of all such equipment, as well as for damage or loss of the equipment. Deposits may be required by **THE CLUB**.

PET REGULATIONS

THE CLUB does not allow pets of any kind in **THE CLUB FACILITIES**, only companion, assistance, or emotional support animals. The owners of these animals or pets must provide the documentation that accredits them in this category. This person can be with their pet in all areas of **THE CLUB** except the Restaurant areas. To have the pet credited under this category, each Member/Multi-member must coordinate prior to their visit to **THE CLUB** or at least upon entry, in order to ensure their proper stay during their visit to **THE CLUB**. The use of a leash at every time is mandatory, for the protection of other Members. **THE CLUB** reserves the right to admit or not admit any pet or animal that it considers dangerous, is very large or does not seem to be under control.

THE CLUB nor its staff members will be responsible for the care and control of pets or animals. The owners of pets or animals are obligated to comply with the orders or instructions that **THE CLUB** personnel give them in relation to the possession and care of their animals while they are in public areas.



Pets must always be with their owners, it is not allowed to leave pets tied in the **THE CLUB** areas, without the supervision of a responsible person, while the owner is in other areas of **THE CLUB**.

The owner or adult responsible for the pet will be responsible for any damage/ acts that the pet does, or the pet suffers while it remains in **THE CLUB** areas.

The owners cannot leave the pet in the custody of minors and are responsible for cleaning up pet waste. The use of **THE CLUB'S** towels on pets is strictly prohibited. It is not allowed to use restaurant utensils to feed pets. Pets are not allowed on chairs, tables, or pool/beach loungers.
